SUMMER AGREEMENT

Summer Payment

I understand that the total summer payment per child is listed on the reverse of this form. **I understand that a deposit for one full session is due at the time of registration and that the total summer payment is due by June 22, 2020 and is non-refundable.**

I understand that there will be no refunds for any absences, scheduled school closings, unscheduled emergency closings or any vacations.

I understand that the cost of programs may change due to changes in costs beyond the school's control.

Additional Fees

I agree to pay a non-refundable registration fee unless my child was enrolled during the previous school year (9/19-6/20).

I understand that if I fail to pick up my child at the pre-arranged time, there will be a \$10.00 late fee plus the normal extended time rate per child.

I agree to pay \$25.00 in the event my check is returned by the bank.

Contract Changes

I understand that Contract changes will only be effective with 5 days written notice, if the school can accommodate the change, and will be effective on the 1st day that the change can be done.

Lunch

I understand that I must provide lunch for my child daily. This should be nutritious, non-perishable food packed in reusable containers, not plastic wrap, and carried in small, soft insulated lunch bags. No sweets.

Child-School Dynamics

I understand that my child's photo may be used for educational or promotional materials.

IN LIEU OF DEVELOPMENTAL SCREENINGS, and in any case when the school deems it necessary, the school reserves the right to terminate service, in which case a refund of unused tuition will be forwarded within 30 days. Therefore, it is recommended that any possible concerns be discussed prior to enrollment.

In order to ensure a relaxed, stress-free atmosphere for all, students are expected to behave in ways that demonstrate consideration for the rights and needs of others and to conform to all rules and regulations. I understand that failure to meet these expectations will lead to restrictions or dismissal.

I understand that Staff exercises the utmost caution and care regarding the safety of the children. I will save and hold the Sprout House Staff Members and Board Members harmless in all situations.
