SUMMER AGREEMENT

Summer Payment

I understand that the total summer payment per child is listed on the reverse of this form. I understand that a deposit for one full session is due at the time of registration and that the total summer payment is due by Monday, June 3, 2024 and is non-refundable.

I understand that there will be no refunds for days my child does not attend camp during my child's scheduled week(s). This means I will not receive camp tuition refunds for sick days, for unscheduled emergency closings, or for any reductions in days or weeks I might choose for my child's camp schedule.

After registering for camp, I may add weeks of camp if there is space for my child, and this request must be done with 5 days written advanced notice.

If my child must drop out of camp due to special circumstances, I may ask for a refund if my child's summer camp placement can be filled by another child, minus a processing fee of \$100.

Additional Fees

I agree to pay a non-refundable registration fee unless my child was enrolled during the previous school year. I understand that if I fail to pick up my child at the pre-arranged time, there will be a \$20.00 late fee. I agree to pay \$25.00 in the event my check is returned by the bank. Drop in for After Care or Before Care is \$20 per session, with one day advance notice.

Lunch and Snack

If my child stays for the afternoon, I understand that I must provide lunch for my child daily. This lunch should be nutritious, non-perishable food packed in waste-free, reusable containers (not plastic wrap), and packed in a small, soft insulated lunch bag. No processed sugar please. For morning and afternoon snack, Sprout House provides fresh fruits and vegetables and healthy crackers.

Child-School Dynamics

I understand that my child's photo may be used for educational or promotional media, unless I opt out of photos.

In order to ensure a relaxed, stress-free atmosphere for all, children and parents are expected to behave in ways that demonstrate consideration for the rights and needs of others and to conform to all rules and regulations, including pool toileting readiness. I understand that failure to meet these expectations will lead to restrictions or expulsion. It is recommended that any possible behavioral concerns be discussed prior to enrollment. If it is deemed necessary to expel a child because of behavior that is harmful to others or him/herself, the school reserves the right to terminate service, in which case a refund of unused tuition will be forwarded within 60 days.

The above terms are understood and agreed to, and I am enrolling my child pursuant to this agreement.

<u>Pool Permission and Sun Block Swim Shirt:</u> If my child is enrolled in *the full day summer program, I* grant permission to Sprout House Staff to walk my child across the driveway to the Borough Memorial Pool. I hold Sprout House Staff and Board members harmless in all situations. I understand that Staff exercises the utmost caution and care regarding the safely of the children. I understand that children are expected to respect public and private property, respect the authority of the teachers and lifeguards, and comply with courtesy in action and language. If my child is enrolled in *the full day summer program*, I will supply for my child a long sleeve UV protection swim shirt to protect my child from sun burn at the pool, and I grant permission to Sprout House staff to apply sunblock.
